The current skating year ends on June 30, 2011, and at that time your membership with *Los Angeles Figure Skating Club* and US Figure Skating will expire. I would encourage you to fill out and return the enclosed Membership Application for the upcoming membership year which runs from July 1, 2011 through June 30, 2012, **as soon as possible** so that your membership does not lapse.

IMPORTANT: Please be sure to fill out the form in its entirety. We especially need your e-mail address as many notifications are sent out electronically. Additionally, we will be sending out the Club Directory electronically as well, with periodic electronic updates to the membership listing on a quarterly basis. If you desire to have a paper directory printed and sent to you, please return your Membership Application along with a short note requesting that a you wish a paper directory to be mailed to you that so one can be printed and mailed to you.

Please note the following special membership offers for specific skaters not applying for Regular or 2nd Club Memberships:

COLLEGIATE MEMBERSHIP is a four year membership for those of you going to college. The cost for the entire four year period is \$105.00. It entitles you to all the same benefits of a regular membership. If you would like to take advantage of this, please provide me with the name of your college, and your college ID. The subsequent three years of your membership with US Figure Skating and LAFSC will automatically be renewed with no additional charges to you. After the four years has elapsed you will then have to renew your membership with the LAFSC and US Figure Skating.

“INTRODUCTORY MEMBERSHIP” is available only to those skaters who have never previously been members of US Figure Skating. If you have previously had a regular membership with US Figure Skating either as an individual or with another club, the appropriate category of membership for you would be a regular membership. If you have any questions, please let me know prior to sending your Application in!

Why should you renew now?

- You want to take a test or compete after June 30, 2011
- You want to skate the club sessions after June 30, 2011
- You are a coach and want to teach on club sessions and have your students be able to compete in qualifying competitions
- You are a judge or official

Please don't wait until the last minute, because it takes time to process the Application, and yours might not get processed in time for that test or competition that's important to you.
